“Haitian Political Conflict and Natural Disasters: A Sustainable Development Approach.”

After the assassination of Haitian President Jovenel Moise on July 7, 2021, actors involving in the conflict are still unable to find a sustainable solution. Moreover, Port-au-Prince, the capital continues to be controlled by armed gangs; the Great South of the country has just been hit by an earthquake on August 14, 2021, killing thousands of people; yet Haitian people still suffer from the after-effects of the 2010 earthquake, which killed more than 200,000 people, around 300,000 were injured and leaving more than a million homeless. To what extent does this situation prevent Haiti from achieving the Sustainable Development Goals (SDGs)? To answer this question, Roland Joseph, the Ph.D. candidate in conflict analysis and resolution at NSU will provide a general overview of the conflict since the assassination of the president until today by identifying the different parties, stakeholders, and actors and provide some insights that can help them address the issue.

Bio of Roland Joseph

Roland Joseph is currently a Ph.D. candidate in Conflict Analysis and Resolution at NSU (concentration: Global Conflict) and is interested in conducting research on the nonkilling paradigm, nuclear conflict, and nuclear weapons risks. He holds a Master of Art in peace and conflict studies from The University of Massachusetts Lowell, a Master of Science in conflict analysis and resolution from NSU, and a bachelor’s degree in political science. M. Joseph is a member of the Research Committee on Non-killing Security and International Relations at the Center for Global Nonkilling (CGNK). Before moving to the US, he worked as a journalist and political analyst in Haiti for numerous radio stations and newspapers for over fifteen years. As a result, he has been interviewed by

some media in Haiti, Haitian Diaspora in the United States, and at the international level about the Haitian political conflict. As a community mobilizer, he has contributed to mobilizing about 14 Haitian nonprofit organizations in the US to support the victims of the earthquake that struck the Great South of Haiti on August 14, 2021. In addition, he coordinated and led training sessions on peace, non-violence, nonkilling, leadership, and conflict resolution at Haiti's Caribbean Center for Global Non-Violence and Sustainable Development (CCNGD).

Dr. LaVena Wilkin Bio

Dr. Wilkin is the Dean of PhD Programs at Sullivan University. She has facilitated workshops on communication, conflict, emotional intelligence, forgiveness, P.E.A.C.E. from Conflict, and workplace bullying for the Center for Non-Profit Excellence, The Archdiocese of Louisville, Integrating Women Leaders, FireKing, Governor’s Equal Employment Opportunity Annual Conference, and so much more. She has created a basic conflict management course and conducted a webinar for the Collaborative Institutional Training Initiative (CITI). She is a contributing chapter to *The Handbook of Mediation: Research, Theory, and Practice*, a co-editor of *Organizational Conflicts: Challenges and Solutions*, and editor for the *Journal of Conflict Management*, co-editor of *From Discord to Harmony: Making the Workplace Hum*, and a chapter in *Search of Stability in an Era of Pandemic* entitled “From Disruption to Connection: How Mindful Conflict Management Builds Bridges During the Pandemic and Beyond. Her latest project, *The Handbook of Organizational Conflict Management* should be available in April 2022. She is a certified mediator, conflict coach and employee engagement facilitator.

Dr. Vitus Ozoke Bio

Dr. Ozoke earned degrees in law from the University of Nigeria and the University of Miami. He graduated with a PhD in Conflict Analysis and Resolution from Nova Southeastern University, Florida. In 2018, he was awarded The Carnegie Foundation African Diaspora Fellowship to travel to Nigeria to help a local university develop a new program in conflict resolution. Dr. Ozoke is the Executive Director of Peace and Leadership for African Nations (PLAN). He is a lawyer, a professor and practitioner of conflict resolution and alternative dispute resolution systems. He is also a trainer in the field of conflict resolution, facilitating workshops for private and governmental agencies, both in Nigeria and the United States. His areas of expertise and scholarly interests include: civil wars and other ethno-political conflicts — their dynamics and their resolution; conflicts of race, gender, sexuality, and their intersections; African indigenous systems of conflict resolution; negotiation and conflict management in business; group dynamics and organizational conflicts; civil societies and mass movements and their roles in conflict; cross-cultural conflicts and multiculturalism in a global world; and human rights, social justice, and legal reforms. Dr. Ozoke is currently the chair of Department of Conflict Analysis and Dispute Resolution at Salisbury University, Maryland.

He later set up a consulting practice doing mediation and facilitation for the public sector, and he is now a Director and Senior Facilitator at Kearns & West. He also is on the faculty of the University of Texas at Austin, where he teaches conflict resolution and an honors course on the myriad ways humans have dealt with conflict over millennia. Dr. Schooler is the author of Truth Talks: North America's Foray into Truth and Reconciliation and a manual on facilitating public meetings—both of which were born out of assignments he had at NSU. Dr. Schooler obtained his doctorate from NSU in 2019. It took him a very long time to finish. Luis is a Harvard-trained negotiation trainer, facilitator, and international/cross-cultural mediator. His recent work includes assessing multiple stakeholders' views across government, civil society, and the private sector. Creating a government environmental agency and exploring how public policy dialogue, negotiated decision-making, and agreement-building strategies could help strengthen the government agency's political viability and effectiveness. Luis has led the assessment of the Peruvian Prime Minister Office's interests in building the government's conflict management capabilities and designing systems to identify social conflicts early and monitor follow-through of agreements.
